SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures:

SECTION 5: FIREFIGHTING MEASURES

5.1 Extinguishing media:

The application should be made by sprayer or other similar equipment, for difficult dirt use a soft brush.

The recommended dilution is 1-part SOLAR WASH PROTECT for 50 parts water (1:50).

Panel cleaning should be done early in the morning or at night when it is cooler. This will minimize the thermal stress of the protective glass.

1° Use the 1:50 wash solution to rinse the panels. Spray on the surface to remove sands and debris from the panels. Wet only the number of panels that can be brushed and rinsed before the product dries.

2° Scrub the panels with a very soft brush (rinse the brush often to clean the sands and avoid scratches on the panels)

3° Spray the surface of the panel to rinse the dirt. Repeat steps 1 and 2 if necessary.

4° Let it dry; or rinse with water; or wipe the panels with microfiber cloth.
